ASCENT AT THE ASPEN INSTITUTE

Anne Mosle is a vice president of the Aspen Institute, founder and executive director of Ascend at the Aspen Institute, and co-chair of the Aspen Institute Forum on Women and Girls. Mosle is a nationally recognized leader bringing philanthropy, policy, and practice together to build pathways to opportunity for children, women, and families.

Mosle founded and leads Ascend, a policy program of the Aspen Institute that serves as the national hub for breakthrough ideas and proven solutions that move low-income children and their parents towards educational success, economic security, and health and well-being. Under her leadership, Ascend has guided the national two-generation field to new heights and catalyzed action and investments for children and families around the world. Mosle led the design and launch of the national Ascend Fellowship program and the first national Two-Generation Innovation Fund and national network focused on policy and practice innovations, which now comprises over 450 partners reaching 10 million people.

Ascend's policy expertise and cross-sector collaboration approach is well respected and has been highlighted in White House forums and hundreds of communities across the country. Mosle is an active contributor to the Aspen Institute policy leadership team committed to tackling the issues of inequality and opportunity in the United States. She has authored and contributed to numerous publications, including State of the Field: Two-Generation Approaches to Family Well-Being (2021), and Toward a More Equitable Tomorrow: A Landscape Analysis of Early Childhood Leadership (2022).

Mosle has achieved numerous awards including Washingtonian of the Year, APHSA's 2017 Jerry W. Friedman Health and Human Services Impact Award, and Visionary Philanthropist. A graduate of the Georgetown University School of Continuing Studies, Mosle currently serves on the board of the Institute for Women's Policy Research, the Executive Governing Board of the American Public Human Services Association (APHSA), the Robert Wood Johnson Foundation State Strategy Advisory Committee, National Trustees Council of America's Promise, and the Leadership Council of the Washington Area Women's Foundation. She lives with her family in Washington, D.C.





IISHA SCOTT
METEOROLOGIST NBC CHICAGO

lisha Scott is an award-winning meteorologist for NBC Chicago. She recently earned the prestigious Certified Broadcast Meteorologist seal from the American Meteorological Society and has won numerous awards for her work.

Before joining NBC Chicago, Scott was the weekend evening meteorologist for WCNC Charlotte and a member of the Emmy Award-winning First Warn Storm Team's 2019 Hurricane Special. As the weekend evening meteorologist at 13News (now in Norfolk, Virginia) Scott was presented with the "Ricky King Service Award" for her coverage of Tropical Storm Hermine. Scott and the 13New Now Weather Team won Virginia's Associated Press Broadcasters Second Place Award for Best Weathercast for their coverage of the January 2018 Blizzard as well as the Meritorious Award for Best Weathercast of the Year for their coverage of Hurricane Matthew.

Scott earned a Bachelor of Science degree in Mass Communications from Norfolk State University, and a Bachelor of Science degree in Geosciences and Broadcast Meteorology from Mississippi State University. Giving back to the community is very important to Scott. While in Virginia, Scott served as President of Hampton Roads Black Media Professionals (the local chapter of the National Association of Black Journalists) and won the Salvation Army Hampton Roads Area Command's "Doing the Most Good" award. She held her inaugural Back to School Vision Board Party in 2016, encouraging young girls to chase their dreams and realize their potential. She is also involved with several mentoring programs. Scott is currently a member of the National Weather Association, the American Meteorological Society, the National Association of Black Journalists, and Alpha Kappa Alpha Sorority, Inc.


